28 November 2014:**23rd General Assembly & 24th Meeting of the Board of Directors of the AACC**

On 28 November 2014, the Austro-Arab Chamber of Commerce invited Their Excellencies the Arab Ambassadors and Arab Diplomatic Corps, together with the AACC's board of directors and members to attend the chamber's 23rd General Assembly, together with the 24th Meeting of the Board of Directors at the "House of Trade" in Vienna.

The President of the AACC **Dr. Richard SCHENZ** opened the meeting by welcoming all participants and sharing an expert's view over the current economic situation and developments in Europe, the Arab countries and in the global context. The **Secretary General Eng. KHOUJA** informed the board and members about the position, activities and membership issues of the AACC as of November 2013 until November 2014. In the statement of the auditors, **Mr. Albert KRONBERGER** and Member of the Viennese Parliament **Dipl.-Ing. Omar AL-RAWI** certified the bookkeeping performance, whereas Treasurer **Mr. Wolfgang KABUREK** presented the financial report for 2013.

In his statement, **Vice-President Nabil KUZBARI** pointed on the present conflicts in the Arab region, and the negative role of the media by blaming religion and "Islam" for the political crises happening in the region. He identified the AACC's duty to inform its members and partners about the "real" Islam, referring to its tolerance and true values. Serving the common interest to improve trade, **Vice-President Henry HAFEZ** identified the power of personal human relations and economy as the

key to overcome problems caused by media or other factors. He therefore recommended a strong cooperation with the AACC, to build up and strengthen the personal network and relations in the region. **Vice-President Prof. Reinhart GAUSTERER** also approved the statements.

The high-level Forum gathered **state presidents, ministers, politicians, businessmen, and other high level representatives from Arab and other countries**, to discuss together prospects and future of investment in Egypt. **Mr. Herbert SCHEIBNER**, former Minister of Defense of Austria, was also attending this event.

The meeting was attended by the Ambassador and Permanent Representative of the Hashemite Kingdom of Jordan to Austria, **H.E. Mr. Hussam Al Hussein**.



The Secretary General of the AACC, **Eng. Mouddar KHOUJA** suggested to strengthen the cooperation between Austria and Jordan in the field of renewable energies, as Austria has achieved a great progress in the field on the European and global level.

H.E. Senator MURAD, who is also President of the Jordan-European Business Association (JEBA) expressed his support for the proposal, stressing that his visit is aimed on discussing ways to strengthen economic and trade cooperation between Austria and Jordan on the private sector level.

He pointed out that Jordan is pursuing a number of legislative and economic reforms to promote the development and intensification of the role of the private sector in Jordan, in addition to the promising investment opportunities and facilities offered by the Kingdom of Jordan to investors in many areas.

31 October 2014:**AACC hosting Closing Reception and Get-Together with UNIDO Delegates and Diplomatic Corps**

On Friday, 31 October 2014, the **Austro-Arab Chamber of Commerce (AACC)** and its cooperation partners, the **Vienna Chamber of Commerce and Industry (WKW)**, the **Vienna Business Agency** and the **United Nations Industrial Development Organization (UNIDO)** were hosting a Reception and Get-Together in the honourable historical hall of the “House of Trade” in Vienna.



The Reception marked the final closing event for the UNIDO Global Executive Programme with focus on “The Future of Manufacturing: Trends and Policy Options”, which was held from 27-31 October 2014 in Austria. The program brought decision makers, experts and representatives of numerous international industry ministries - including ministers, state secretaries and directors - together to discuss trends and concepts for sustainable industrial development and production in the global context, and to develop strategies for future implementation. The high-level delegates were coming Argentina, Chile, China, Costa Rica, Dominican Republic, Ecuador, Egypt, India, Iran, Jordan, Laos, Malaysia, Mauritius, Mongolia, Nigeria, Pakistan, Philippines, Seychelles, South Africa, Sudan, St. Lucia, Swaziland, Timor-Leste, Turkey and Uruguay.



The President of the AACC **Senator Dr. Richard SCHENZ** welcomed the delegation and the honourable guests that were also present, including their Excellencies the Ambassadors and representatives from the Arab and international diplomatic corps, together with cooperation partners and representatives from other institutions and the Austrian industry sector. He also gave a short welcome address in the name of the Vienna Chamber of Commerce and Industry (WKW) in his

function as the Vice-President of the Austrian Federal Economic Chamber (WKO), the umbrella organisation of the federal chambers in Austria.



In a short presentation, the Secretary General of the AACC **Eng. Mouddar KHOUJA** gave an overview on historical and economic facts about Austria and introduced the AACC and its recent activities. He also presented to the audience the current trade volume statistics between Austria and the delegates' respective countries by comparing the data from 2013 and 2014 and indicating economic trends and developments in this context.

17 September 2014:**AACC participates in Panel Discussion on “Cooperation during Conflict - Possibilities of Technical Cooperation in the Middle East”**

On 17 September 2014, the Secretary General of the Austro-Arab Chamber of Commerce, **Eng. Mouddar KHOUJA**, was invited as one of four expert speakers at a panel discussion focusing on “Cooperation during Conflict – Possibilities of Technical Cooperation in the Middle East” at the Vienna University of Technology.



The panel discussion was organised by the **Engineering Cooperation**, an initiative of graduates of different scientific and technological universities in Austria, who want to combine their acquired knowledge and socio-economic engagement by taking responsibility through supporting innovative approaches in technical, economic as well as political collaborations.

Prof. Dr. Adalbert PRECHTL, Vice-Rector for Academic Affairs of the Vienna University of Technology, opened the panel with a warm address of welcome. **Eng. Stefanie PYKA** and **Eng. Magdalena BÄUERL** from the organisers gave a short introduction to the chosen topic of the panel by informing the audience about the challenges for technical experts to participate in projects and programmes in conflict areas such as some regions in the Middle East. The objective of the panel was to share and discuss possibilities of sustainable cooperation in conflict areas with experts from politics, economy and science, together with students and the interested audience.

Mag. Anton MAIR, Deputy Director General of Development Cooperation and Head of Evaluation, Development Policy and Strategy at the Austrian Federal Ministry for Europe, Integration and Foreign Affairs presented an overview about Austria’s development cooperation policy in the field of education. He mentioned the dual and tertiary education as main focus areas, and informed the audience about recent programmes to strengthen and develop cooperation between educational institutions through scholarships, capacity and cluster building and student exchange programmes. Austria shares USD 5,9 Million on development aid in the Palestinian territories, and is working

together with the Palestinian National Authority, local NGOs and capacities, educational institutions and humanitarian organisations, he informed.

For **DI Helmut JUNG**, project leader and Professor at the University of Natural Resources and Life Sciences of Vienna (in retirement), the transfer of scientific knowledge for technical cooperation in conflict areas needs the consideration of socio-economic factors and the dialogue with the local conflict parties. "Conflict" – in opposite to "war" – can also lead to new solutions and approaches; therefore, scientists should try to understand the conflict, and incorporate this knowledge, together with the consideration of natural and technical components, into their scientific approach, he advised. In a short field report, DI JUNG also referred to his own work experience in Gaza, Palestine in 1996-7, where a project for a water desalination plant was finally successfully installed in a joint project supported by the Austrian Development Agency, the Palestinian Water Authority, the Islamic University and the Bir Zeit University, while they had to overcome several conflicts, barriers and obstacles imposed to the Palestinian expert team.

Mag. Christian LASSNIG, Trade Delegate of the Austrian Federal Economic Chamber in Israel and Palestine from 2007 until 2013, gave an insight about the challenges of operating economic offices in conflict areas, and referred to recent temporary closings of offices in Bagdad, Damascus and Tripolis. On the other hand, Austria's trade volume with Middle Eastern countries of crises such as Iraq, Egypt or Tunisia was nevertheless showing a stable continuity, except for Syria. By comparing Israel and the Palestinian territories regarding general economic data and Austria's flow of commodities, Mag. LASSNIG gave an indication about the immediate interrelation of economic disadvantages and conflicts. He defined the role of Austria's economy in active conflict intervention between Israelis and the Palestinians as reluctant, explaining that an apparent economic involvement towards one conflict party could immediately cause mistrust and irritation among the other party. The destruction of solar panels - installed by the NGO Comet-me to provide Palestinian Bedouins in Hebron with electricity - by Israeli settlers in March 2014, was just another recent example of how difficult it could be not only to implement cooperation projects, but to keep them sustainable in areas of conflicts and crises.

Eng. Mouddar KHOUJA, the Secretary General of the Austro-Arab Chamber of Commerce (AACC), presented an expert's insight on the great role and economic potential of the Arab countries. He stated that the region which covers a vast area of 13 million sqm, does not only hold 63% of the world's natural oil and 21% of the world's gas reserves, but is also considerable market and potential of human resources with its 330 million inhabitants. He identified various sectors for cooperation possibilities, including agriculture, transport, IT, health, banking, tourism, education and energy, and connected recent revolutions and political developments in some countries with tendencies to fight corruption, install proper governance and transparency and support economic growth. Successful economic cooperation does also depend on general conditions and requirements, as Eng. KHOUJA explained: Austrian companies are therefore recommended to involve into strategic partnerships with international enterprises to realize greater projects; the issuance of visas for businessmen should be less bureaucratic; Austrian politicians should offer their support and lobbying to back their country's economic activities and interaction with Arab partner countries. A thorough understanding, sensitivity and respect towards their partner's culture, language and religion was also a key factor for successful economic cooperation, he informed. In response to the question whether economic interests in a region can also enforce immediate involvement through external powers, Eng. Khouja referred to what was happening in Libya during the last revolution in this context. Political instability, corruption, different understandings of migration and economic interaction, as well as differing

interests to realize an economic partnership can impose challenges for sustainable economic cooperation, he concluded.

The following discussion with the audience was moderated by **Eng. Stefanie PICHLER** from the organizing Engineering Cooperation.

10-11 September 2014:

The AACC participates in Forum on “Investment Prospects in Food Security and Mineral Resources” in Sudan



The Austro-Arab Chamber of Commerce (AACC) participated in the activities of "the Investment Prospects in food security and Mineral Resources Forum" which was held in the Sudanese capital Khartoum on 10 – 11 September, 2014 under the auspices of the President of the Republic of the Sudan, and jointly organized by the General Union of Chambers of Commerce, Industry and Agriculture for Arab Countries (Union of Arab Chambers / UAC) and the General Union of Sudanese Businessmen and in cooperation with the Ministries of Finance, Investment, Agriculture and Minerals as well as the Union of Sudanese Banks.

The Forum was attended by a great number of officials, ministers, businessmen, Arab and foreign investors. At the opening session the Vice-President of Sudan H.E. Dr. Hassabu Mohamed ABDALRAHMAN, H.E. Adnan KASSAR, Honorary President of the UAC, H.E. Mr. Mohamadou Ould Mohamad MAHMOUD, President of the UAC, Mr. Musaed Mohammed AHMED, Head of the Union of Arab Banks and Mr. Saud AL BARBIR, President of the Federation of Sudanese Businessmen as well as the Forum’s guest of honor Sheikh Saleh Abdullah KAMEL delivered speeches.

During the four sessions of the Forum the discussions focused on a number of issues such as "the necessary reforms in the investment environment and food security, the ways to find a financial mechanism to support investment projects, the supporting initiatives to promote investment and the support of the Sudanese initiative to convert food security into reality, as well as a review of the prospects for investment in mineral wealth."

Vice-President H.E. Dr. Hassabu Mohamed ABDALRAHMAN focused in his speech on the measures taken in Sudan to facilitate the entry of Arab investments in the fields of agriculture, industry and minerals. He called for Arab investors to invest in his country's natural potential to achieve Arab food security. He also stressed on the efforts made by the country to overcome the obstacles for Arab investments and to facilitate the steps for investors in the country.

In his speech the Minister of Investment, H.E. Dr. Mustafa Osman ISMAIL mentioned that his country will adopt soon a new investment law to solve the problems faced by investors in Sudan. The measures to facilitate investment includes, according to Minister Ismail, the establishment of a special court to deal with settling disputes in the investment sector as well as a special public attorney's office and a special police force as operational tools. Minister Ismail also revealed a plan to invest 30 billion dollars in the agricultural field, which makes Sudan the second Arab country in terms of the value of investments in this area.

The Honorary President of the Union of Arab Chambers, H.E. Adnan KASSAR said that he believes in the faith of Arab investors in Sudan as the basis and future of the Arab food supply and as a source of natural resources. He pointed out in his speech to the Union's commitment in supporting Sudan to achieve Arab food security. In turn, the President of the Union of Arab Chambers H.E. Mr. Mohamadou Ould Mohamad MAHMOUD said that the Forum aims to enhance communication between all concerned sectors to achieve Arab food security, and to promote investment in Sudan and the Arab world.

The CEO of Al Baraka Banking Group and former President of the Union of Arab Banks, Mr. Adnan Ahmed YOUSEF, referred to some of the demands and concerns of investors, calling to adopt banking policies which support stability. He asked the Sudanese government to increase the funding of research in the field of agriculture and to establish special programs in this regard, in addition to providing the necessary economic and legislative facilities to businessmen. In turn, Mr. Musa FREIJ, Chairman of Wadi Group, stressed on the need to develop the necessary legislation to limit the influence of squatters on agricultural land, in order to preserve the rights of investors in the agricultural sector in Sudan.



On the sidelines of the forum, a meeting of the directors and secretaries-general of the Arab and Arab-foreign joint chambers was held and chaired by Dr. Imad SHEHAB, Secretary-General of the Union of Arab Chambers. The meeting focused on the social responsibility of the chambers in strengthening work culture and supporting entrepreneurship.

In this context, the Secretary General of the Austro-Arab Chamber of Commerce Eng. Mouddar KHOUJA mentioned six examples, namely:

The AACC's submission of a proposal to the King Abdullah b. Abdulaziz International Centre for Interreligious & Intercultural Dialogue (KAICIID) in Vienna to hold a conference on the role of religious values in the global economy, planned for 2015.

The AACC's cooperation with the Institute of Oriental Studies of the University of Vienna to create a section for Arab Studies at the university that includes lecturers from Arab universities.

The AACC's initiative in collaboration with Austrian official bodies and sectors of the Austrian civil society to provide humanitarian relief to Syrian people in cooperation with the International Red Cross.

The AACC meetings with Austrian ministers and ambassadors in Arab countries, which made the AACC a reference for the different Austrian intellectual communities and institutions in view of Arab economic affairs.

The AACC's online Job Bulletin for both, job seekers and providers of employment opportunities such as Austrian companies, institutions as well as embassies operating in Austria.

The AACC's role as a hub in building scientific bridges through networking between Austrian universities and scientific institutions in Arab countries such as in Saudi Arabia, Qatar and Sudan. The AACC's activities in establishing good relations with international scientific personalities such as Professor Dr. Heinz BRANDL, a world expert in geotechnical engineering, dams and flood protection, road and railway engineering, municipal and hazardous waste deposits.

18-19 June 2014:**AACC participates in Ministerial Session of the Second Arab Forum for Renewable Energy and Energy Efficiency**

Upon the invitation of the Department of Energy of the League of Arab States, the Secretary General of the Austro-Arab Chamber of Commerce Eng. Mouddar KHOUJA, moderated the ministerial session of the Second Arab Forum on Renewable Energy and Energy Efficiency. The forum was held from 18-19 June 2014, with the participation of the League of Arab States, the Economic and Social Commission for Western Asia (UN-ESCWA), the Regional Center for Renewable Energy and Energy Efficiency and the EU-MED-ENEC Energy Efficiency in the Construction Sector in the Mediterranean.

H.E. Dr. Mohamed SHAKER, Minister of Electricity and Renewable Energy of Egypt, H.E. Dr. Omar KATTANEH, Minister of Energy, Palestine, H.E. Dr. Mervat TALLAWI, Chairperson of the National Council for Women, Egypt, the Ambassador of India to Egypt H.E. Navdeeb SURI, and Eng. Ahmed EL SEWEDY, President and CEO of Elsewedy Electric took part in this Ministerial Session.

In his speech, Eng. KHOUJA pointed out that the population in the Arab world is doubling every three decades, while in Western countries only every 114 years. The energy use per capita is in a continuous rise but the efficiency of the available energy is weak. The indicators show that the proportion of conventional energy exceeds 65%, while alternative and renewable energy is less than 35%.

Eng. KHOUJA emphasized the role of the Arab region with regard to energy resources, whether traditional or sustainable ones. The Arab countries have about 25-30% of the world's oil and natural gas, in addition to the sun, the largest source of sustainable and renewable energy, which is available in these countries throughout the year, along with the availability of wind power in some Arab countries. He pointed out that alternative energy is not alien to the Arab region, as the idea was already used in the waterwheels of Hama in Syria and the Maarib Dam in Yemen.

The Forum, which lasted for two days, discussed the issue of strengthening the role of small and medium enterprises in the fields of renewable energy and energy efficiency. It was divided in five working sessions: The ministerial round table which offered insights on the mechanisms of long-term transformation of the energy on the national level, followed by three sessions on the role of small and medium enterprises in the development and use of renewable energy, energy efficiency including challenges and solutions, based on the lessons learned and the enabling environment. The last session was a panel discussion about major renewable energy projects versus small capacity renewable energy projects. On the third day, the Regional Center for Renewable Energy and Energy Efficiency organized in collaboration with the United Nations Industrial Development Organization some sessions for professionals in the field of renewable energy.

On the sidelines of the forum, H.E. Eng. Jamila MATAR, Director of the Energy Department in the League of Arab States, presented the Memorial Shield of the Forum to Eng. Mouddar KHOUJA in recognition for his participation in this important event.

2 April 2014:**Forum on investment opportunities in the GCC countries**

On 2 April 2014 the **Austro-Arab Chamber of Commerce (AACC)** organised the **Forum “Arabian Gulf – Yes, but how?”** in cooperation with the **International Forum for Business Communication (IFWK)** and the **Vienna Business Agency**.



During a very active discussion in **the Expat Centre of the Vienna Business Agency**, **Eng. Mouddar Khouja**, the AACC’s Secretary General, emphasised the huge project volume in the GCC countries, especially in the infrastructure, energy and water sectors and advised Austrian companies to establish partnerships to increase their competitiveness for big projects in the region. Considering Europe’s and in particular Austria’s vital interest to diversify its energy resources, a further increase of the trade relations between Austria and the Gulf states could help to reach this goal, i.e. by importing liquid gas from the GCC countries.

Further participants of the forum were: **Mr. Yahya Al Dugaishi**, Counsellor at the Embassy of the Sultanate of Oman, **Mr. Werner Baumgartner**, President of the Austrian Business Council in the United Arab Emirates, **Mr. Klaus Billinger**, Consultant in the UAE, and **Eng. Franz Schauer**, Managing Director of the construction company AST Baugesellschaft. The discussion was anchored by **Mrs. Bettina Gneisz Al-Ani**, university professor and former Head of Business Communication at OMV.

In his presentation **Mr. Baumgartner** highlighted the enormous potential of the Gulf region, particularly with regard to the Expo Dubai 2020. He referred to recent positive developments in Dubai to emphasise this: the prices for real estate have increased by 20%, share prices have risen by approximately 140% and most hotels are already now nearly fully booked for the coming years. However, there is still potential in the tourist sector, as the number of visitors to Dubai is expected to increase significantly by approximately 150%, reaching 25 million visitors per year.

Despite the attractive market conditions in the GCC countries, bureaucratic barriers can present big challenges for Austrian companies, according to **Mr. Franz Schauer**. He described the intention to establish a company in this region as a long and often complicated process. However, as soon as the company was fully registered it could participate in tenders for large projects.



After the discussion the audience had the chance to direct their questions to the panelists. Among the esteemed guests of the forum were **Mr. Rudolf J. Melzer**, founder of the International Forum for Business Communication (IFWK), **Mag. Sabine Ohler**, Head of International Services at the Vienna Business Agency, **Ms. Isabella Mader**, MSc, Chairman of the Excellence Institute – Research & Solutions, **Mr. Walter Marchl** from Energie Effizienz Austria, **Mr. Kai von Buddenbrock**, Director of Bossard Austria, and **Ms. Raphaela Vallon-Sattler**, Secretary General of the International Advertising Association. 25 March 2014:**AACC Secretary General presents economic key figures about the Austrian Federal States to the Council of Arab Ambassadors to Austria**

On 25 March 2014 the Secretary General of the Austro-Arab Chamber of Commerce **Eng. Mouddar KHOUJA** was invited to present an overview of the Austrian economy and the economic key figures of the 9 Austrian federal states to the Council of Arab Ambassadors to Austria.

As indicated by Eng. KHOUJA, the Austrian GNP reached 361 billion USD in 2013, representing an increase of 4 billion USD compared to 2012. The GNP per capita was about 42.600 USD in 2013, occupying rank 21 internationally before Germany and Great Britain and after Luxemburg, Norway and Switzerland. Austria's national debt was 75.7% of the GNP in 2013, 3.7% more than 2012.



Eng. KHOUJA also pointed out the low level of unemployment in Austria compared to other states of the European Union. In the year 2013, the unemployment rate was 4.9% according to "Statistics Austria".

As the business and trade relations between Austria and the Arab countries is concerned, the Secretary General highlighted the trade volume between the two regions, which reached 4.86 billion EUR in 2013 and was composed of 59% exports and 41% imports. In the past year 2013, the business relations between Austria and the Arab states reached their maximum, whereas Saudi Arabia, the United Arab Emirates, Libya and Kuwait were the most important trade partners for Austria.

Furthermore, the presentation to the Council of Arab Ambassadors included the most important Austrian exports to the Arab States, as well as the terms of trade between the Austrian Federal States and the Arab region in 2012. Additionally, economic figures of the 9 federal states were provided, stating the most important Austrian products exported to the Arab States.

Concerning the trade volume of the 9 Austrian federal states with the Arab region, Lower Austria occupies the first rank, followed by Upper Austria, Styria and Vienna. However, Salzburg and Vienna are the most attractive tourist destinations with the highest number of Arab visitors compared to the other Austrian federal states.

Eng. Khouja expressed the readiness of the Austro-Arab Chamber to coordinate visits of the Arab Ambassadors to meet governors of the Austrian federal states. He specially emphasized the possibility to benefit of the Chamber's cooperation with the national chambers of the federal states to organize meetings with the Ambassadors, as well as visits to major Austrian companies.



Additionally, Eng. Khouja referred to the decision of the Council of Ministers of the EU agreed on Monday, 24 March 2014 to tighten the terms of the Savings Taxation Directive of the European Union and the related secret bank accounts of Non-EU residents, which allows the Tax Authorities of the EU to exchange information about the savings income of Non-EU residents inside the EU which is hidden in secret accounts.

The national rules for transposing the revised Savings Directive have to be adopted by the Member States by 1 January 2016. The amendments of the Tax Directive are expected to be applied to the following Non-EU Member States: Switzerland, Liechtenstein, Monaco, San Marino and Andorra.

Upon request of the President of the Council of Arab Ambassadors, **H.E. Salahaldin ABDALSHAFI**, Ambassador of the State of Palestine to Austria, Eng. KHOUJA introduced the chamber's activities on 22 May 2014 on occasion of the 25th anniversary of the Austro-Arab Chamber of Commerce, **the 7th Arab-Austrian Economic Forum & Exhibition** as an international business event.

Secretary General meets with CEO of STRABAG

At the beginning **Mr. Franz URBAN** welcomed the attendees, and gave a brief about the company and its role in the field of building and construction in many countries of the world. He pointed out that the company has been established since 1835, making it one of the oldest construction companies in the world. Mr. Urban explained that the area of Central and Eastern Europe is the main market for Strabag, in addition to strategic projects in the Arab region, such as the UAE, Qatar and Saudi Arabia, where Strabag is operating since more than 30 years, and Oman in which the company has projects since more than 20 years.

Eng. Omar AL-RAWI, speaking as Chairman of the Employees Representative Union at Strabag, mentioned that Strabag has the highest level of performance and quality, especially with regard to dealing within the institution and with the employees. He added that the Union represents the company's employees and workers in all parts of the world and expresses their problems, concerns and demands. Strabag also invests in the implementation of social projects, especially in Eastern Europe, and obtains about 50% of the construction projects in Austria.

In a speech on behalf of the current President of the Council of Arab Ambassadors, **H.E. Salah ABDEL SHAFI**, Ambassador of the State of Palestine to Austria, **Counsellor Hazem SHABAT** thanked the Austro-Arab Chamber of Commerce for the initiative to communicate with the Austrian important institutions.

The Director General of UNIDO receives AACC delegates

Mr. LI Yong welcomed the intention to intensify the relations between UNIDO and the AACC, especially through activities focused on reducing unemployment, creating job opportunities for young people, the development of vocational training and education.

Mr. Li Yong, who took over as Director-General of the United Nations Industrial Development Organization (UNIDO) in June 2013, has had an extensive career as a senior economic and financial policy-maker. As Vice-Minister of Finance of the People's Republic of China and member of the Monetary Policy Committee of the Central Bank for a decade, Mr. LI was involved in setting and harmonizing fiscal, monetary and industrial policies, and in supporting sound economic growth in China. He pushed forward financial sector reform, and prompted major financial institutions to establish corporate governance, deal with toxic assets and strengthen risk management. Mr. LI gave great importance to fiscal and financial measures in favor of agricultural development and SMEs, the cornerstones for creating economic opportunities, reducing poverty and promoting gender equality. He played a key role in China's cooperation with multilateral development organizations, such as the World Bank Group and the Asian Development Bank.


